During the conference, it is planned to hold a plenary session on the declared subject and breakout sessions **on topics:**

- Novels of inheritance law
- Prospects for the development of family law
- Family and inheritance law through the prism of intellectual property
- Dialectics of family, inheritance and corporate law

The conference will be held in a mixed format. Russian and foreign scientists, lecturers from leading universities, practitioners, post-graduate students and students are invited to take part in the conference.

All abstracts that meet the formal requirements should be taken for blind peer review. A positive decision to present a report at the conference will be made only if the report corresponds to the subject of the conference and the requirements of scientific character.

## **Appendix 1**

### Requirements for abstracts

1. Microsoft Word text editor in .doc or .docs format; font - Times New Roman, type body size - 14 pt; alignment - in width; paragraph indentation - 1.25 cm; line spacing - one and a half; margins: left - 2.5 cm, right - 1 cm, top and bottom - 2 cm; automatic hyphenation; pagination at the top (right);
2. The text must be accompanied by information about the author (full name, academic degree, academic title, place of work, e-mail address);
3. The volume of submitted abstracts should not exceed 2 pages;
4. The name of the file with the materials should contain the author's surname (Surname-Report.doc/docs).

## **Appendix 2**

### Requirements for the texts of reports for publication in the collection

1. Microsoft Word text editor in .doc or .docs format; font - Times New Roman, type body size - 14 pt; alignment - in width; paragraph indentation - 1.25 cm; line spacing - one and a half; margins: left - 2.5 cm, right - 1 cm, top and bottom - 2 cm; automatic hyphenation; pagination at the top (right);
2. The text must be accompanied by information about the author (full name, academic degree, academic title, place of work, e-mail address);
3. The volume of the text of the report should not exceed 7 pages;
4. Paginal footnotes;
5. The list of references should not contain regulatory legal acts.
