MESSAGE FROM THE CONFERENCE PROGRAM COMMITTE

Dear Colleagues!

We are glad to welcome you into and on the Internet platforms of the Higher School of Economics! These December days we organize the International scientific and practical conference "Justice and Reconciliation: Cumulative Effects", which will collect representatives of various centers of scientific thought, leading experts and practitioners. We hope that the conference will allow us to discuss problems of organization, implementation and development of professional reconciliation activities that concern us carried out both in justice and in related spheres of public life, grounds and prospects of their mutual influence and enrichment.

Reconciliation institutions have existed for a large number of years, having appeared even before the appearance of the state and law in their modern understanding. Over the last 20 years in the Russian judiciary the serious processes of implementation of reconciliation in procedural legislation and judicial practice took place. New stage of development of these procedures was opened by approval on October 31, 2019 by the Plenum of the Supreme Court of the Russian Federation the so called Guide of judicial reconciliation, extending its effect for civil, administrative and arbitration processes, as well as developed by the Ministry of Justice of the Russian Federation in 2020 the draft of the new federal law "On the settlement of disputes with the participation of an intermediary (mediation) in the Russian Federation".

The criminal justice, unlike other types of legal proceedings, from our point of view, is only just before the complete discovering of the institute of reconciliation: in criminal law and criminal justice this institution exists, but the procedures for achieving that reconciliation has not yet received any criminal procedural regulation neither at the level of law, nor at the level of sublegal acts defining technologies for the implementation of the reconciliation procedures, rehabilitation programs or other mediation practices. In 2019-2020 experts of the Council under the President of the Russian Federation for Civil Society and Human Rights initiated a bill on the implementation of the institute of reconciliation in criminal proceedings, which fills the indicated gaps. This bill is undergoing expert discussion and will be the subject of attention of the conference participants.

Manifestations of the institution of reconciliation, existing in one way or another in almost all types of legal proceedings in modern Russian legal system, give us a good reason at our conference to systematically evaluate in the framework of its role and significance in Russian justice. It is also important to comprehend the interconnection of procedural mechanisms of traditional (state) justice and reconciliation (mediative, restorative) technologies: the latest, developing parallel to the usual procedural forms of consideration and decisions of cases by state courts, but, being integrated into the activities of state courts, are able to provide a considerable positive influence on all Russian Justice.

As key issues for discussion at the conference offered:

• The theoretical basis and limits of use of reconciliation legal procedures in Russian justice

• The most successful practices of reconciliation and the possibilities for its integration into national justice

• Procedural and legal regulation of reconciliation procedures in civil, administrative and criminal proceedings: the current state and key developments

• Out-of-court reconciliation at the service of human rights institutions (in the activities of ombudsmen, lawyers, notaries, arbitration courts etc.)

• Reconciliation in international justice: the limits of application and the necessary procedural forms

• Legal and social effects of the application of reconciliation procedures in the public justice procedures
